

REPORT ON BARGAINING

GOVERNMENT MANDATE PRESENTED WHAT DOES IT MEAN FOR YOU AND YOUR FAMILY?

Public service workers are facing troublingtimes as the Wall Government carries out their plan to address their deficit byreducing our wages and benefits.

We expect employers to preserve our fundamental rights and benefits, not take them away.

Since Wall's government has been in place, publics ervices have been reduced, privatized or eliminated. Over the years, we have been able to maintain our fundamental rights and benefits during bargaining. Now, the Wall government has publically announced their bargaining mandate to attack these fundamental rights and benefits that we fought hard to achieve. Your Negotiating Committee and Bargaining Council strongly oppose any rollbacks to wages or benefits.

On January 20, 2017, your Negotiating Committeemet with the employer. In addition to their previous proposals, the employer raised a number of items they want to discuss to reduce overall compensation costs.

The employer stated compensation costs mustremain at the 2016/2017 levels. They also stated they will be looking into furtherreductions into the future. The employerwants to have discussions around:

- freezing increments for anyone who has not reached the maximum of their level of pay, meaning employees will not receive an increment for many years;
- rolling back pension contributions;
- zero economic wage increases;
- employees to pay premiums for health and dental benefits;
- unpaid vacation days.

In addition to this, the employer indicated they will continue to review the Collective Agreement for further options to reduce compensation costs.

This is the worst mandate from the Provincial Government we have ever seen.

As employees we were not responsible for:

- squandering a rainy day fund of \$1.5 billion;
- giving \$2 billion to a French company for the Regina Bypass;
- spending hundreds of millions on consultants;
- spending \$47 million on smart meters;
- spending \$33 million on LEAN;
- creating three additional MLAs at a cost of \$700,000 per year;
- losing approximately \$25 million per year in revenue due to the privatization of liquor stores:
- contracting out some Information Technology services at three to four times the cost of doing it within Executive Government;
- increasing compensation costs for Executive Council by 74% between 2009 and 2016;
- giving raises of 25% to Wall's Chief of Staff and 33% to his Communication Director since 2009.

Now the government wants us to pay for the mismanagement.

Regional meetings have been scheduled around the province and are identified in this update. Plan to attend the meeting being held in your area. We will be providing updates regarding the government's mandate and the effect it will have on you and your family.
