Dear members,

The SGEU Health Providers negotiating committee is preparing to proceed to the next stage of bargaining with the Saskatchewan Association of Health Organizations (SAHO), the Saskatchewan Health Authority (SHA), SEIU-West and CUPE 5430. All parties met on September 23 in Regina to discuss the process for upcoming common table negotiations.

We are happy to share that we confirmed five bargaining dates this year and another three in the new year. They are:

- October 20 – 24
- November 3 – 7
- November 18 – 21
- December 1 – 5
- December 15 – 19
- January 19 – 23
- February 5 – 6
- February 17 – 20

At the common table we will be discussing anything with a monetary value, including general wage increases.

The SGEU Health Providers negotiating committee is optimistic as we proceed with the next step of bargaining and look forward to bargaining alongside our fellow workers at CUPE and SEIU-West.

Negotiations can be challenging, but we want to reassure you that our members' best interests guide every decision we make. We will continue to keep you informed each step of the way as we work towards a fair and respectful collective agreement.
