OH&S Committee Manual

The Occupational, Health and Safety (OH&S) Standing Committee is currently working on a committee manual. A copy of this manual has been created to track changes and to record suggestions for changes to wording in the Constitution in order to implement into the Committee Manual to propose the changes at next year's Convention. These changes will be recorded as resolutions to Convention and Lorna Hamilton will submit after the Committee's fall meeting.

Workplace OH&S Committee Contact List

These statistics show that safety incident numbers are going down; OH&S initiatives are being taken seriously in the workplace. The stories allowed the participants to think more about identifying themselves in situations.

Website Updates

 The Right to Know...
 - You have the right to know about any hazards you may encounter in your workplace, and how to protect yourself from them.
 - You should receive safety and health training and instruction before you begin work, and when your work changes.
 - You should be under the direction of a competent supervisor who can show you how to perform your work safely.

The Right to Participate...

- You have the right to participate in a workplace Safety and Health Committee if there are 20 or more employees in your workplace.
- You have the right to have a Worker Safety and Health Representative if there are between 5 and 19 employees in your workplace.
- You have the right to ask for additional information or voice a concern related to safety and health hazards to which you may be exposed.

The Right to Refuse Unsafe Work...

 You have the right to refuse work that you believe is dangerous to your safety and health or to others.

The Right to Protection

- If you exercise a right or carry out a duty under the Workplace Safety and Health Act or Regulations, you cannot be disciplined or discriminated against.
- This includes using your right to refuse unsafe work, or reporting a safety and health concern to your supervisor, a Safety Committee member, the Worker Safety Representative, your Union or Workplace Safety and Health.

Workplace OH&S Committee Member Position Election Package

The Workplace OH&S Committee Member Position Election Package has now been approved by Provincial Council and consists of:

- Call for Nominations
- Member Nomination Form
- Member Acceptance Form
- Member Position Registration Form

We will request that Billie create fillable forms and then post the forms as one document on the website as the 'Workplace OH&S Committee Election Package.'

Union/Management OH&S Committees

Kelly Hardy, Rod McCorriston and Bob Bymoen attended the meeting to discuss the issue of union representation on workplace OH&S Committees and the process going forward. After detailed discussion in this regard, it was decided to work on ideas to incorporate into a letter that would be addressed to the Sector VPs. .

Various comments/discussion around this topic included:

- List of Stewards attached to the Committees and the requirement for Committees.
- Get list of all workplaces and someone needs to contact.
- Meet with the Sectors to enquire what they are doing to support their Stewards.
- Not having a Committee is NOT an option in the workplace.
- The Union needs to have a staff member assigned strictly to OH&S.
- Advise Provincial Council we need resources, one person designated to OH&S and ensure compliance to the legislation and to report back to this Committee.
- ➤ Go to the locals first by contacting the Chair of every local.
- Inform the employers by way of providing Steward list who will then identify the OH&S Committee members.
- Did you know......In-scope supervisors/stewards are responsible for their workplace OH&S Committees? Until our LD is developed, we should at least incorporate a segment into our existing LDs introducing OH&S.

- In order for the employer to be compliant with the law, they are obligated to hold the elections for workplace OH&S Committees.
- > This Committee needs to recruit/train/enforce.
- ➤ Identify where the Stewards are and start recruiting OH&S Committee members. Do not need to be Steward but need to be a designate of a Steward.
- Due to lack of Stewards, the employer has designated employees for their workplace OH&S Committees. Not the correct process, but better than no process at all.
- Accept the employer's appointment of these Committees, but each Committee should hold a formal election.

Colin Byas (employee of SUN/CUPE member) Presentation

Colin Byas provided a brief educational on how to become a recognized training agency and to become capable of delivering Levels 1 and 2 (safety and supervision) and other recognized training as per LRWS/WCB expectations:

- Application within the Ministry facilitators have to apply to do this on an individual basis. You can be certified as an entity.
- Large drive to complete this training online, to have more people qualified as trainers, and to condense the material.
- Larry Buchinski will meet with Michael Sherar to obtain Colin's Level 1 and 2 course information on a USB (the education process). All content based on Saskatchewan. Facilitators need to be certified individually.
- The goal would be for SGEU have their own trainers, where Worksafe recognizes us as an approved training facility.
- CUPE National year of health and safety. 17 modules with 3 mental health modules. 9 hour introduction to health and safety is mandatory. 9 more sessions. This is a much more productive course than the old Level 1 and 2. Allows the ability to take further than the Committee level. Colin has sent the information on CUPE's education they offer their members to Lorna and Larry.

CBA Language

Health Sector is requesting suggestions for language to include in CBA - needed by January 2, 2017. Lorna will forward the Committee's revised CBA notes.

OH&S Education Development/LD

Larry did a 2 hour presentation for the Health Sector in Watrous on November 8, 2016, he has distributed copies of the material and provided a brief on topics discussed. There is ongoing work on the Leadership Development (LD) material and review of the ideas and proposed course material. Larry will meet with Michael to discuss considering developing an FAQ for new employees.

Michael indicated that a 'complete 1 hour orientation for OH&S' will be done by a Union representative. It is mandatory that the employer complete their part in terms of the workplace OH&S Committee. Each Sector would need to individually agree to move forward with this. Orientation starts with simply going onto SGEU's website, directing to the OH&S Standing Committee page. Level 1 and 2 course information will be placed on a USB memory stick concerning the education process. All content based on Saskatchewan. Facilitators need to be certified individually. It has been identified that it is CUPE National's "Year of Health and Safety". 17 modules with 3 mental health modules will be presented. 9 hours of introduction to health and safety is mandatory. The committee feels that this is a much more productive course than the old Level 1 and 2. Colin has sent the information on CUPE's education they offer their members to Lorna and Larry. We need to ask CUPE if we can share this information with SGEU members. The Committee discussed incorporating the 'workers rights' information into the existing LD 5. We need to keep expanding the OH&S education as the LDs progress to 10, 20 and so forth.

OH&S Scholarship

Due to the overwhelming response on this scholarship, additional budget was requested to award two \$500 scholarships in 2017. Both \$500 scholarships are to come out of the Committee's budget.

Prize for SGEU OH&S Award to be presented at Convention

Richard Schramm provided the Committee with the roadside assistance kit. Roseann is getting "SGEU OH&S" screen printed on the outside of the kit. Request that Paulette Kidd email the SGEU OH&S Award form to all Sector VPs, Chairs, Vice Chairs and Secretaries. Also, the form will be posted on the website. The committee will research prices to get a recognition tree made to mount the winning recipients' names on plaques to affix to the tree each year. Nominations will be sent to Larry and will be reviewed by the OH&S Standing Committee at the March 2017 meeting, prior to Convention. The award will be presented at Convention by the Chair of the OH&S Standing Committee.

The committee will also consider nominating these people for the WCB Safe Worker and Bob Sass Awards.

Silent Auction Items at Convention

The committee members will be looking for silent auction donations or contributions for Convention 2017. Group email to keep communication open regarding silent auction items. Lorna has emailed Chris Day regarding the possibility of the Committee having a silent auction items at Convention, as a fundraiser for scholarships funds.

Evaluation of WCB Compensation Institute - Highlights and Low Points

One highlight is the real truth life stories. There was a strong impact by the guest speaker, Spencer Beach. He was a survivor of a chemical burn who had 3rd and 4th degree burns to 95% of his body. His doctor told him he had a 5% chance of living. After 14 years and35 surgeries later Spencer is waiting for another surgery, he has an amazing outlook in life and he has extraordinary reasons for safety. This speaker stressed the importance of reading and following the MSDS forms – had this been done, this incident would not have happened.

Another highlight was the speaker, Karl Bossung, Director of Consulting from DEKRA Insite. He talked about himself and his experience of knocking on 14 doors, informing people that their family members were not coming home. This was due to missed steps in everyday work duties. He said that staff could have easily prevented these incidences if people would have not taken shortcuts.

Another impactful speaker was Wolfgang Zimmerman, President of Pacific Coast University for Workplace Heath Sciences. He was injured on the job 40 years ago on his second week of work. He was a pioneer who initiated the Return to Work Program.

Another guest speaker, Ed Secondiak, President of ECS, talked about how new marijuana legislation will possibly impact our workplaces.

Another positive highlight was the mental health presentations. They indicated taking stigma off of mental health injuries and celebrating return to works as if they were the same as physical injuries. We also gained an understanding that our Workers' Compensation is more advanced than Germany and even the United States. One low point was the speakers that came from the United States, as their presentation was irrelevant to the Canadian Workers' Compensation system. Overall, another great year that the Committee has taken valuable information away from and to take to their workplaces.

Workload

The committee would like to take something to NUPGE Working Group about Workload issues at SGEU – big issue in healthcare, corrections, community service. Since there have been many cut backs and management is still expecting the same amount of work done with less people. Shift workers are working overtime with double shifts and driving home after – this is worse than being impaired because of "Shift Paralysis". Lorna responded to union member's concern at Kelvington Lodge.

By June 13, 2018, the committee would like to have information on workload issues. The committee needs to go discuss this with the sectors and find out specific examples to identify problems. Examples needed: heavy lifting, not enough staff/coverage, stress PTSD, work/life balance, burnout, repetitive strain injuries, recognition and reward. Review to see if there is anything in the CBAs to help with workload issues? Casual pools, job shares, contracting out – should be hiring more staff instead, summer students/ bursary students. Review existing workload tracking form (SEIU West & SEIU Healthcare examples): add insufficient equipment/ppe. The committee discussed that workload issues = work injuries = high costs for employers. The committee also discussed adding / updating information to the Shift workers' poster?

Violence in the Workplace

This is a big issue in healthcare sector and corrections. Lorna and Beth will take this topic to the NUPGE OH&S Working Group for ideas.SASWH has developed Violence in the Workplace training for all types of jobs.

NUPGE OH&S Working Group

The conference will be held on June 21 & 22, 2018. Both Lorna and Beth will be in attendance. The committee identified some issues for Sectors: Workload & Staffing Levels/Cuts & Manager vs Staff Levels, Violence in the Workplace – Healthcare & Corrections, Cannabis in the Workplace, Fentanyl Crisis, Mental Health. SGEU OH&S Standing Committee Representatives will take: SGEU Fentanyl Poster, SGEU 3 Rights Card, SGEU Shift Work Poster. PTSD: What is province/sectors doing on PTSD? Mental Health Fist Aid Training being done at SGEU, we should suggest to SFL to add some training as well.

Other topics of discussion could be WorkSafe Saskatchewan Mental Health info, Asbestos, 3 Rights Wallet Card, OPM Safety Culture Survey and Safety Management System Assessment Tool, Youth Safety Training.

Bob's Report

Occupational Health and Safety Representatives
Conference Call: November 8, 2017, Ottawa, ON

Component: SGEU

1. Government/political climate

SGEU has a base of approximately 20,000 members. The membership is recognized within 6 sectors. The sectors are:

- 1. Public Service. This sector is comprised mainly of employees of Executive Government Ministries, The PSGE Bargaining Unit. It has approximately 12,600 members.
- Crown Sector which is represented by employees from 13 different bargaining units mainly from Treasury Board Crowns such as the Workers Compensation Board or Saskatchewan Assessment management agency which reviews property values for municipalities. The Crown Sector has approximately 1500 members.
- 3. Health Sector. This sector is comprised of members from the Health Districts (Provider Units) Cancer Agency and an ambulance company. It has approximately 2300 members
- Education Sector is comprised of members from Sask Polytechnic, Regional Colleges, Northlands College, Gabriel Dumont Institute. The Education has approximately 2000 members.

- 5. Community Based Sector is comprised of members who work for community based organizations providing assisted living and care, crisis intervention, settlement assistance for new Canadians, and mental health support. The Community Services Sector has approximately 1000 members.
- 6. Retail Regulatory which is comprised of employees of Sask Liquor and gaming. They work in the warehouse, distribution and retail of liquor (public stores) and they provide regulation and enforcement of the gaming industry and distribution of alcohol. The Retail Regulatory sector has approximately 900 members.

2. Collective bargaining update

Collective bargaining has been at a standstill for over a year. The government announced that everyone was to take a 3.5% roll back. SGEU is challenging this as bad faith bargaining at the Labour Relations Board. There is basically no appetite at the table to offer any CBA improvements. Most of SGEU and most Public Sector workers are without a current contract.

3. Significant grievances

SGEU has approximately 160 outstanding grievances. It is hard to provide a short summary of a single grievance. In general,

- We have seen a spike in disciplinary grievances within Corrections,
- Accommodations are harder to get resolved in some cases,
- The tolerance for sick leave usage is less than the past.
- Healthcare still has lots of issues related to scheduling.
- Our most significant grievance challenges the employer's changes to the Wildfire Fighter's fitness test and the accommodations or lack of accommodations stemming from the test. The details are long and the outcome is under review so we can't get into detail at this time.
- We put a strong focus on resolving issues where possible.

4. Major campaigns and communications

We have been running campaigns since shortly after the Sask Party was elected in 2007. This year we hosted 3 large rallies at the Provincial Legislative buildings and dozens of other events. The government tabled a long list of cuts in the March 2017 budget. Cuts to Education, Healthcare, seniors, children with autism, almost all of the library funding, the Provincial Bus Company (STC) was closed on budget day, public sector employees were budgeted for a 3.5% reduction in salary. The government has reversed many of the cuts. They have brought the 3.5% cut to the bargaining table. We are rejecting their proposals.

5. Government inquiries or reviews

Have there been any major government mandated reviews or inquiries of the sector in your province?

The government calls it transformation. The finance minister states that no rock will be left unturned. The largest review is Healthcare where they are moving to one Health district effective December 4th, 2017. The unions are lobbying the government to persuade them that the amalgamation of districts does not have to change union representation nor trigger a representation vote amongst the 5 Health provider unions. The government says there will be only one health district but it has created 6 health authorities and has changed the boundaries of the health regions.

The WCB Committee of review was conducted in 2015 and the report was released in November 2016. The WCB is pondering a different appeal process that would be more expensive. PTSD and mental illness are starting to gain some interest.

6. PTSD

- Does your province have presumptive legislation?
 Yes, unless the employer objects then the WCB looks at the file.
- So, who is covered?
 Everyone with a psychological injury
- What does this mean for Workers' Compensation claims and staffing?
 Not aware of any significant change
- Do your Component and its constituent unions have collective bargaining language regarding PTSD or mental injury?

• Has your Component undertaken any major initiatives in PTSD/mental injury? The Provincial Council received 4 hours of training on PTSD. We offer Mental Health training through Canadian Mental Association. Our CMHA members deliver it. We sponsored a Masters Studies student to do her Thesis on PTSD in Corrections about 15 years ago and received some startling information. This was shared with Corrections management. I don't recall any major changes to policy resulting from this but it did start a discussion and awareness within Corrections.

7. Fentanyl/opioid crisis

- Have any members been injured or adversely affected through exposure to fentanyl or an opioid in their workplace/on the job?
 Not to our knowledge
- Have your Component and its constituent unions developed any educational material on the proper way to respond to possible workplace/on the job exposure We have not developed any material. Some of our employers are providing training and changing operating procedures because of this issue.
- What other measures have been adopted to respond to the crisis?
 Corrections has changed their mail handling processes.

8. Any other major activities to report

- How are components tracking OH&S Committee members?
- Do they send regular communications to them?
- The caregivers, Continuing Care Assistants/Special Care Aids that provide the care in our nursing homes are 80% of the injured workers in healthcare. Actually they have been one of the most hazardous occupations in Canada for the past number of years and yet the employer still wants to blame the injury on the worker and will not even consider the fact that workload could be a contributing factor. How do other provinces address this issue?
